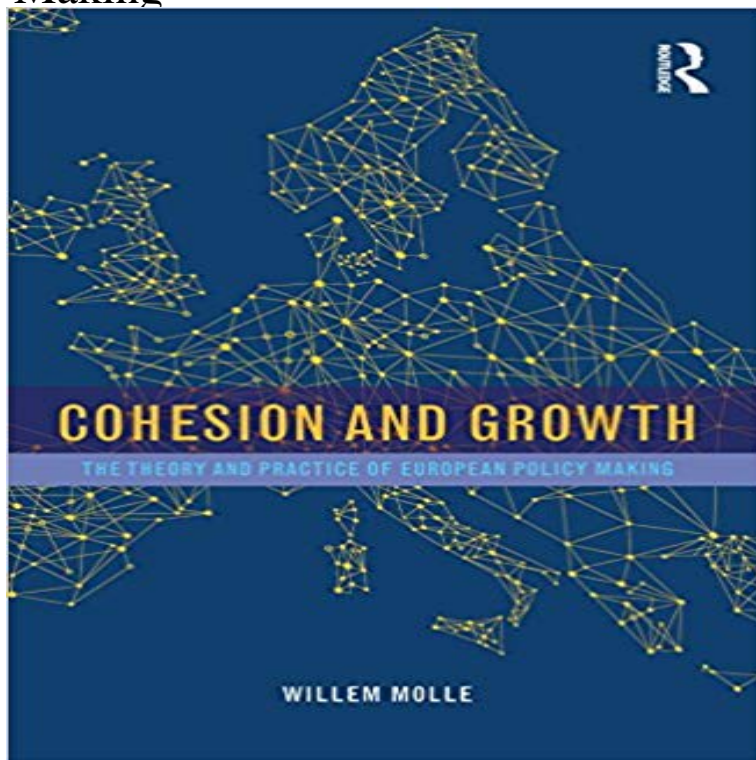


Cohesion and Growth: The Theory and Practice of European Policy Making
