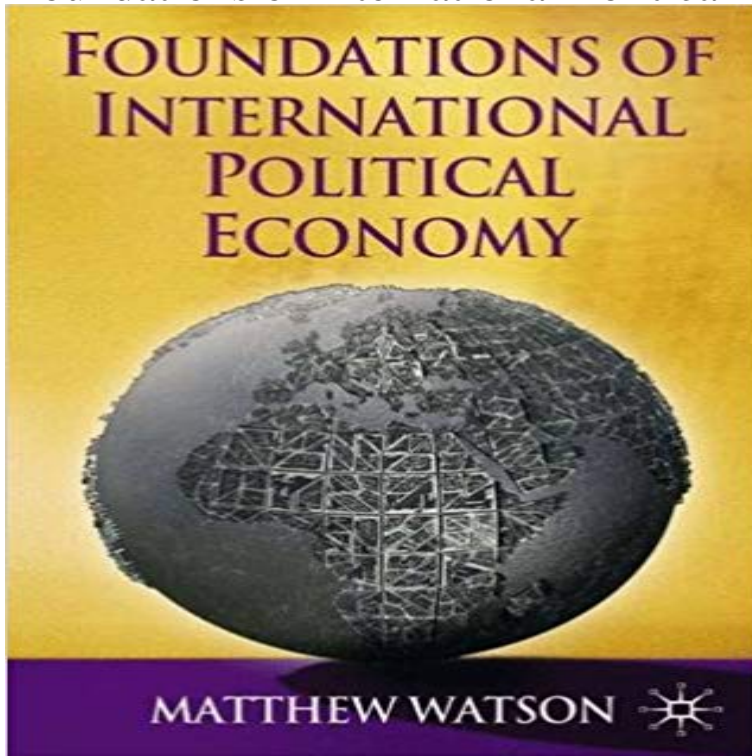


Foundations of International Political Economy
